In the past, Government has been supportive of self-regulation within our Industry, but the last 12 months have seen ever-increasing rumblings about 'regulation of the internet'. These rumblings come, not just from our own Government, but from the European Union too, and they are very much to do with the representation and protection of end users.

The end user is now very much a focus of government thinking. Just two examples of this are "A Government Perspective" [1] by David Hendon, BERR, and the BERR letter to Nominet last October [2] that refers to self-regulation and wider stakeholder interests.

I believe the elected members of the PAB should take the initiative in the Policy Development Process by shaping policy recommendations that show a clear awareness of government and end user concerns and that represent the views of all stakeholders. I believe as Members, we need to accept our collective responsibility towards the wider stakeholder community, not just from a commercial perspective, but from a socially responsible one too.

To this end, I think it is vitally important that communication between Members and the PAB is radically improved, not only for the sake of the Membership, but so Government can see the Memberships' commitment through its elected PAB representatives, to the end user.

No matter what may be promised in some of the election statements you read, please bear in mind, it is not the job of the PAB to micromanage Nominet or its Board, the job of the PAB is to create policy recommendations that encompass intent, responsibilities, standards, and objectives. The PAB can do this more effectively with more ideas and more support from you, the Members. If you elect me, I will do my utmost to improve communication between the PAB and the Membership so that all your views are represented within the policy development process. www.nic.uk/policy/develop/flowchart.

I have already served on the PAB from 2004 to 2008. In my 2006 election statement I wrote: "how Nominet interacts with its members can have a butterfly effect on other stakeholder groups". Ironically, the events of the past few months have turned that statement around. I could now say, how members (and some board members) interact with Nominet has already had a profound butterfly effect on all stakeholders, and indeed, on the credibility of the Membership as a guiding force within the Nominet ethos.

I think it is imperative that all Nominet members look at constructive ways of moving the self-regulation debate forward in an informed and professional way. Google says: "focus on the user and all else will follow". It's not a bad philosophy by which to set the standard for .UK Policy that could inspire and help shape the development of internet governance on the international stage.
